Sub: Clarification regarding Transfer to same category post under General Transfer Rules, 2015.

Ref: His Memo No. 479/6449/CSSC/ESTY/2016 Dated 27.06.2016

With reference to the above the undersigned is directed to say that after issuance of this department's htemo No 687-SE/S/15-08/16 dated 24.05,2016 question has been raised from different corners regarding maintenance of Register of Appointment (ROA) in a school where a teacher or non-teaching staff will be appointed after gotting transfer.

To resolve the confusion it is clarified that every transferee shall have to be placed in ROA of the recipient organisation in the following manners as explained in clause 2 of Memo No 4977-MR-33/15 of BCW Deptt dtd 18/12/15.

If the transferee belongs to unreserved category, his joining shall be adjusted against an available unreserved Roaster Point. If such Roaster Point is not available, but a vacancy in reserved RP is available, then the incumbent will be placed in available reserved RP and this Reserved RP will be carried forward to the next Un Roaster Point as is provided in the West Bengal Scheduled Castes and Scheduled Trabe (Reservation of vacancies in Services and Post) Act, 1976 vide section 6(2). While executing this 'carry forward method' vertical reservation shall be considered subject to applicability of horizontal reservation in Roaster Point.

Implementing repeated 'Carry forward' as per 2(a), will not amount to multiple violation of Roaster Point to ROA provided it is marked as per Para (a).

If the transfered belongs to reserved category, his joining shall be adjusted against an available reservation Roaster Point of the same category, if such Roaster Point is not available, but a vacancy in any reserved /unreserved RP is available, then the incumbent will be placed in that RP and this Reserved RP will be carried forward to the next UR Roaster Point of the same rategory.

to implementing Para 2(a) 'carry forward owing to transfer ' should be recorded by the competent authority in the 'Regularization Order' and in the 'Remarks' column of ROA
